


**Pre-bid meeting for the Job of Audit of projects supported by Innovative/Challenge Fund
under the Kolkata Urban Services for the Poor (KUSP) Programme

Proceedings

The meeting started with a welcome note from the CMU and self introduction by all the participants. A brief presentation was made regarding the job on offer followed by detailed discussions. Consequent to the discussions, following points were resolved.

1. Financial proposal shall be submitted as per the format provided by the CMU. Bids will be evaluated on weighted scores basis and 70:30 weights to be allotted to man-days:bid price while evaluating any proposal.
2. CMU reserves the right to reject any or all proposals without showing any reason thereof.
3. For any unreasonable financial proposal by a Firm, CMU shall reserve the right to de-list that Firm from its empanelment and inform the same to the Institute of Chartered Accountants of India and CAG of India.
4. While placing the invoice claim, the selected Firm shall also submit self attested Statement of man-days showing project wise details of manpower actually deployed including name and designation while doing the assigned job. In case the number of man-days deployed is less than ^{that} offered, the claimed amount may be proportionately reduced.
5. Last date of submission of Bids will be 25.11.2010. up to 12 Noon. No bid will be accepted beyond this date and time under any circumstances.
6. The financial proposals will be opened at 1.00 PM on.25th of November 2010 at the office of the undersigned.
